About Our Council

he County of Carlow (Contae Cheatharlach) is located inland within the South East of Ireland in the province of Leinster covering an area of 896 square kilometres. The County is strategically located and has excellent access to transport infrastructure through its location on the M9 Dublin Waterford motorway, the Dublin Waterford main rail line and the N80 national road linking Rosslare Europort to the Midlands.

The population of County Carlow recorded in the 2016 census was 56,932. The county town of Carlow is located in the northwest of the County along the border with County Laois.


Carlow Town (including Graiguecullen) had a population of 24,274 recorded in the 2016 census making it the thirteenth largest urban centre in the state.



Register of Electors

The Council is responsible for the compilation of the Register of Electors for the County Carlow. The Register of Electors is produced annually and the Register of Electors for the period 2021/2022 issued on the 15th of February 2021. The total number of electors registered to vote in 2021 was 44,117 (Carlow Local Electoral Area 16,425, Tullow Local Electoral Area 14,652 and Muinebheag Local Electoral Area.

Corporate Property

The Corporate Affairs Section is responsible for all Corporate Property (Except Social Housing and Roads) and the maintenance and upkeep of same. It is also responsible for leases of property to and from other parties.

Business in the Community Ireland (BITCI)

Carlow County Council have been involved for several years now with the BITCI skills @ Work Programme in partnership with Tyndall College. This program encourages school completion and gives the student the opportunity to consider the many and varied career and study options open to them when they finish school. Students gain insights into the working role of Carlow County Council within their community, and they see first hand potential career paths that can be open to them.

The students did not miss out in 2021 as the CCC delivered this programme online. The students attended a number of online talks on the services, roles and responsibilities of local government, 'a day in the life' talk where CCC staff gave an insight into various careers within local government, followed by a remote visit to the Council Chamber. The final phase of the programme involved Corporate Affairs delivering CV and interview preparation advice to the students followed by mock interviews and delivering feedback by Corporate Staff.

The annual assessments of the scheme have been very positive over the last number of vears.

Data Protection

Carlow County Council processes all personal information in accordance with the General Data Protection Regulation 2016 and the Data Protection Acts, 1988 to 2018. The General Data Protection Regulation (GDPR) applies from 25th May 2018. It has general application to the processing of personal data in the EU, setting out more extensive obligations on data controllers and processors, and providing strengthened protections and rights for data subjects. The Data Protection Officer (DPO) has actively engaged with sections in carrying out Data Privacy Impact Assessments and addressing any risks identified. Training continues to be rolled out to staff, and various policy documents have been developed including department Privacy Statements, Data Protection Breach Management Policy, Clean Desk Policy.

Human Rights

Section 42 of the Irish Human Rights and Equality Commission Act 2014 places the Duty in the context of strategic planning. Requiring public bodies to have regard to the need to eliminate discrimination, promote equality of opportunity, and protect the human rights of staff and service users. Carlow County Council takes a leadership role in social inclusion, equality, human rights and universal accessibility.

Freedom of Information

The Freedom of Information (FOI) Act 2014 gives legal rights to those seeking access to information held by public bodies covered by the Act.

Records Management and Archives

Corporate Affairs is responsible for the implementation of the National Retention Policy for Local Authority Records, and for development of the County Archives Service. In 2021 CCC procured a new Archives Centre to ensure that records are documented and archived correctly. The Centre is located in a unit on O'Brien Road in Carlow Town.

Council Meetings

Carlow County Council has **18** Elected Members which represent **3** municipal districts of Carlow, Tullow and Muinebheag. Corporate Affairs manages CCC Council Meetings, Carlow Municipal District Meetings, Corporate Policy Group meetings and Deputation. In 2021 due to Covid, CCC meetings moved to a hybrid model or fully remote in order to ensure continuity.

Chief Executive Monthly Progress Report to Council

The Chief Executive prepares a report on the performance of each directorate/section during the month following the previous monthly report. This report is an agenda item at every monthly Council meeting and questions are taken from members on any aspect of the report. This report also serves as a mechanism through which members have oversight of the progress on the implementation of the Corporate Plan. A copy of the Chief Executive's monthly report is also forwarded to the Department of Housing, Planning, Community and Local Government each month.

Health And Safety


arlow County Council is committed to managing and conducting its work activities in such a way as to ensure, so far as is reasonably practicable, the safety, health, and welfare at work of its employees and others who may be affected by its business activities.

In response to the COVID-19 pandemic, Carlow County Council continued throughout 2021 to implement an effective COVID-19 management system across the organisation in accordance with public health, government, and local authority sector advice and recommendations.

The prevention of accidents in the workplace is of utmost importance. Accidents/Incidents are investigated to determine the root cause and prevent reoccurrence. During 2021, 9 work related accidents and 2 near misses involving Council staff were recorded.

Carlow County Council is committed to promoting a safety culture, giving staff new skills and knowledge, and developing good safety procedures on the job. 20 health and safety training courses were held in compliance with Covid-19 requirements. Carlow County Council continued with its workplace safety inspection programme during 2021 as a tool to monitor and maintain health and safety standards. Inspections are carried out on an ongoing basis and require effort and commitment by all staff across the organisation. The reward for this effort is continuous improvement of safety standards and no serious accidents.

Carlow Fire Service received an external surveillance audit of their Occupational Health and Safety Management System to ISO 45001 standard during December 2021.

he overall objective of the planning department is to promote the development of the County in a manner which facilitates sustainable economic and social progress. The day-to-day operation of the department covers a number of functional areas namely development management, planning enforcement, compliance, taking in charge of residential developments, derelict sites, dangerous structures and forward planning.

Development Management

Carlow County Council received a total of **527** planning applications during 2021. The following is a breakdown of decisions made during 2021 by Carlow County Council:

Enforcement

The planning department in accordance with the Planning and Development Act 2000 (as amended) seeks to ensure that planning permissions are complied with. All written complaints of unauthorised development, where they appear to be well founded, are investigated. Following an investigation of a bone fide complaint the commencement of the enforcement steps are initiated by the issue of a Warning Letter followed by the issue of an Enforcement Notice should the matter not be satisfactorily resolved following the issue of a Warning Letter. In the event of non-compliance with the Enforcement Notice legal proceedings are

initiated. A total of **111** complaints were received during 2021.

Vacant Site Levy

The Planning Department continued to progress during 2021 the establishment of a Vacant Site Register as provided for under the Urban Regeneration and Housing Act 2015, as amended by the Planning and Development (Amendment) Act 2018. The Vacant Sites Register is available to view online on the Council's website at www. carlow.ie. Entries are made on the Register following the completion of site assessments and the issuing of notices pursuant to the Urban Regeneration and Housing Act 2015, as amended by the Planning and Development (Amendment) Act 2018.

Short-Term Lettings

The Planning and Development Act 2000 (Exempted Development) (No. 2) Regulations 2019 gave ef-fect to legislation regarding Short-Term Lettings. The legislation came into effect on 1st July, 2019. On 26th September 2019 the Carlow Local Electoral Area was designated as a Rent Pressure Zone and consequently, new regulations regarding Short Term Lettings were enforceable by Carlow County Council during 2021.

While the Covid-19 Pandemic did impact on the Short-Term Lettings market within the Rent Pressure Zone an increase in activity was recorded in the final quarter of 2021.


Carlow County Development Plan 2015-2021 Review:

The review of the Carlow County
Development Plan 2015-2021 continued
during 2021 with the prepara-tion and
publication of the Draft Carlow County
Development Plan 2022-2028. The Draft Plan
was con-sidered by the Elected Members at
a Special Council Meeting held on 2nd July
2021 and was approved by resolution subject
to amendments. Public consultation on the
Draft Plan took place over a period of 10
weeks and closed on 1st October 2021.

The Chief Executive's Report on the submissions received issued to the Elected Members on the 24th of November 2021. Formal consideration of the Chief Executive's Report took place at a Special Council Meeting held on the 3rd February 2022.

The Elected Members resolved to amend the Draft Carlow County Development Plan 2022-2028 as rec-ommended by the Chief Executive and as further amended by way of motions and resolutions agreed at the meeting.

Carlow Tourism: Carlow County Council supported the Annual Plan for Carlow Tourism under their MOU with Carlow Tourism and strategic framework for the future support of the Tourism Sector in County Carlow.

Community Enterprise Centre

Carlow County Council secured €87,000 funding in partnership with Carlow Community Enterprise Centre and commenced development of a strategic framework for expansion of the enterprise and incubation space footprint for County Carlow in 2022 and beyond.

Ireland South East Office

Carlow County Council provided funding to the Ireland South East Office for the co-ordination of a variety of actions in the area of economic development and business support. The Council published the South East Remote working study on behalf of the South East Local Authorities and engaged in the development of the New Regional Jobs Plan.



Promotion of National Women's Enterprise Day

Economic Marketing

Carlow County Council commissioned a variety of publications in association with the Sunday Business Post, Sunday Independent, RTE Guide, KCLR and the Nationalist during 2021.

Christmas 2020 Programme

Carlow's Christmas Programme, County Carlow - A Festive Family Experience, was a completely Hybrid programme due to Covid-19 restrictions, but huge engagement was recorded throughout the campaign. Programmes included a Schools Competition, a Light Up Carlow Campaign, a Window Display Competition, a PR Campaign in partnership with KCLR, and a Be Local Online Campaign. A physical launch event was in Carlow Town Hall Car Park attended by 2,500 people.

Special Project Development & Delivery Urban Regeneration & Development Fund Project Carlow 2040

Carlow County Council completed and launched the URDF Project Carlow 2040 Plan during 2020 and prepared a URDF application. Project Carlow 2040 is an ambitious Regeneration Strategy for Carlow Town. This Regeneration Strategy contains transformational and inspiring ideas for the economic, social and environmental benefit of Carlow.

The Council continued to lead the delivery of Craft Hub under Creative Europe.

Bottle Banks

In 2021, Carlow County Council facilitated the recycling of 1,358.14 tonnes of Glass and 47.41 tonnes of Cans at all our 28 sites throughout Carlow and once again it is an increase on the previous year.

An additional bottle banks site was opened at Ardattin in August 2021. Since these banks were put in place 4.09 tonnes have been recycled.

Powerstown Civic Amenity Site

During 2021 Powerstown Civic amenity site continued to provide full service to the public despite the effects of the Covid 19 pandemic and associated restrictions. Approximately 1700 hours of waste and recycling services were provided during 2021.

In 2021 a total of 31,507 customers were served at Powerstown. 2,635 tonnes of material was removed from the site. 1,306 tonnes of this material was used to produce energy from waste. 119 tonnes of material was disposed to landfill. 1,210 tonnes of material went for was recycling / recovery.

The Civic Amenity site continued to accept bikes for Africa during 2021 and a total of 135 bikes were sent for refurbishment prior to shipment to Africa.

In June 2021 a very successful Paint Amnesty was operated at Powerstown CAS during which 293 customers deposited 12 tonnes of paint for disposal. Following the amnesty new charges were introduced to allow for the continued acceptance of paint at the site.

A bulky waste amnesty was operated during August allowing 333 customers to deposit 52 tonnes of bulky household items. 745 mattresses were collected in September as part of a successful mattress amnesty.

The EPA conducted an online site inspection during 2021 during which site management procedures were assessed, compliance reporting, leachate and gas management, groundwater and surface water monitoring and VOC emissions. Weighbridge records and tonnages were also assessed. The results of the inspection was that all areas assessed

Farm Inspections

A total of 68 farm inspections were carried out in 2021 for GAP Inspections, pollution complaints, planning inspections, biosolids spreading inspections and source protection Inspections. Where problems were found they were largely associated with silage effluent collection, poor soiled water management, inadequate slurry collection, poor gutters and downpipes in yards and inadequate maps for sludge spreading.

Climate Action and biodiversity initiatives / achievements:

Carlow Climate Action Team, Members and staff received Climate Capacity Training Climate Action for Carlow workshops for our community.

Let's Talk Climate Action Workshops gave an introduction to climate science, its impacts & possible solutions, helping communities to identify climate actions at a local level. Carlow County Council were delighted to support County Carlow Environmental

Network in hosting an informative & interactive workshop to support Biodiversity in Carlow

During 2021 Carlow beekeepers expanded their apiary on site at Powerstown Landfill and the facility was used to host educational events and training workshops for prospective beekeepers.

A number of birdboxes were installed at Powerstown during 2021, following survey and advice from Birdwatch Carlow. It is hoped that these will be used during the 2022 nesting season.

As active members, Carlow County Council hosted the annual All Ireland Pollinator Plan Conference in 2021.



Launch of Bag it Bin It - Dog Fouling Campaign.

Carlow County Council, in partnership with Kilkenny, Wexford and Waterford County Councils launched the "Bag It Bin It" antidog fouling campaign. This campaign is designed to remind dog walkers to take responsibility for their dog waste and to ensure that they not only use a bag to pick it up but ensure that they place the waste into any general litter bin.

This regional campaign has 5 stages/ Themes.

- **1** Brand Awareness / your responsibility
- 2 Who is affected? Profiling community
- 3 Behaviour of Dog Walkers
- **4** BIN It addressing those who bag it, but don't bin it appropriately
- **5** Supporting each other based on the green dog walkers programme

Energy

Carlow County Council continued to collaborate with the 3 Counties Energy Agency in 2021 to deliver on energy saving targets and to promote energy awareness through various programmes. By the end of 2020, Carlow County Council had achieved a 39.9% reduction in energy consumption since the baseline was set in 2009. Under the National Energy Efficiency Action Plan (NEEAP) and the Public Sector Energy Efficiency Strategy, every local authority was required to achieve a 33% improvement on its energy efficiency by 2020 from a baseline year of 2009.

During 2021, targets for 2030 have been set and energy savings are required to bring a reduction of 50% on the baseline with an absolute carbon reduction of 51%. This target is challenging and together with the Climate Adaptation Strategy, measures will need to be agreed to achieve the targets. The Better Energy Communities Programme in 2021 continued to support communities, SMEs and households through grant funding available through the SEAI. Carlow County Council received support for the LED lighting programme.

Wastewater

There were 22 incidents reported to the EPA during the year, only one was related to an ELV failure, six were breakdowns of items of abatement equipment, nine related to adverse weather power outages and

overflows from plant in Rathvilly (each time the storm tank over flows there it is reportable), six were network issues (blockages at siphon in Tullow, or other sewer overflows).

The EPA carried out four Audits (Two OEE Audits at Ballon WwTP and Carlow Town WwTP, two ORM Audits were carried out at Borris WwTP and Bagenalstown WwTP. The EPA also carried out a site inspection following a spillage/pollution incident to the sewer network in Tullow.

Since January 2014, Irish Water, the national water utility is responsible for the delivery of water and wastewater services. Carlow County Council and Irish Water agree to work under the terms of a 12-year Service Level Agreement (SLA) to provide efficient and quality water services to satisfy the needs of the customers in compliance with the statutory and regulatory requirements. In 2021 the SLA set targets across a number of operational measures, tracking measures and also 18 key performance indicators. These targets and objectives are spread across financial, procurement, internal



process/compliance, customer service, Workflow, CDS, leakage management, asset operations, DW &WW Environmental Regulation, HSQE, AER's, Capital Projects, Process Optimisation and Energy Management.

Capital Works

Capital Works progressed during 2021 across multiple Water and Wastewater Capital projects.

Planning permission was granted, and a detailed design developed to upgrade Rathvilly Water Treatment Plant.

Works completed through the Water Network Programme commenced in conjunction with the Regional Contractor. Works include the replacement of water mains and backyard services in the JKL/ O'Hanrahan Avenue area of Carlow town. As part of this programme a large portfolio of works were also approved in 2021 with planned construction in 2022.

In Tullow, construction commenced in August 2021 to upgrade the Wastewater Treatment Plant. Plans for a pump station and sewerage network upgrade in the town were also progressed.

The design for the upgrade of Bagenalstown Wastewater Treatment Plant was finalised and planning permission was granted.

The scope of the upgrade works for the Carlow Town Wastewater Treatment Plant increased in 2021 to include a pumping station and some elements of the network, and the detailed design was progressed.

The contractor for the design and upgrade of Borris Wastewater Treatment Plant was appointed and a design was submitted for review.

arlow County Council maintains Fire Brigades in four Fire Stations located in Carlow Town, Muine Bheag, Tullow and Hacketstown. A Fire Service Training Centre utilised by Fire Services from across Ireland is also based in Hacketstown Fire Station. The dedicated crews, together with modern vehicles and equipment, ensure delivery of a prompt, efficient and effective service responding to a total of 540 incidents on a 24/7 basis in 2021 resulting in 596 mobilisations by Carlow Fire Brigades. The operational response is supported by the Eastern Regional Control Centre located in Dublin Fire Brigade HQ in Townsend St, which receives calls from the public through the 999/112 service and mobilises the appropriate fire service resources in County Carlow.

Services such as administration, fire prevention activities, Building Control, Major Emergency Management etc. are delivered from the Fire Service Headquarters at Green Lane, Carlow Town.

The lifting of COVID 19 restrictions during 2021 which were introduced in March 2020 had a notable impact on the number of emergency incidents which Carlow County Fire Service attended. The total number of emergency incidents attended in 2021 (540) was approximately 17% higher than the number attended in 2020 (466).

The Local Authority Performance Indicators Report 2020 carried out by NOAC (National Oversight and Audit Commission) which was published in September 2021 highlighted the fact that Carlow Fire Authority had the 4th lowest cost per capita for the entire country at €34.32 per head of population. This compares favorably when compared against the national average of €62.69 per capita.

The NOAC report also highlighted that in 98% of mobilisations, a crew from Carlow Fire Service arrived at the scene of an emergency incident within 20 minutes from time of mobilisation.



Applications for Fire Safety Certificates were granted within the statutory period of 2 months in 63% of cases, ahead of the national average of 54%.

Safety, Health & Welfare

In December 2021, Carlow Fire Service's safety management system was certified to ISO45001 by the National Standards Authority of Ireland. This is confirmation of the safety management system in Carlow County Fire & Rescue Service complying with international best practice and also recognition of the work and dedication across all sections and levels of the service required to achieve this standard.

In order to achieve this award, a 2-day audit by the National Standards Authority of Ireland of the Fire Services Occupational Health and Safety Management System. The awarding of ISO 45001 means that the organisation is internationally recognised in an elite category of businesses, one of a small number of fire services that have attained this standard in Ireland.

Carlow County Fire Service was shortlisted in the Public Service Category of the Excellence in Health and Safety Awards in July 2021, the County Fire Service was shortlisted along with the Mater Miscordiae Hospital, Waterford Institute of Technology and Gas Networks Ireland.

Capital Funding

On December 29th, Minister for the Department of Housing, Local Government and Heritage Darragh O' Brien announced a new €61 million Fire Service Capital Programme. As part of this announcement, Carlow Fire Service has been allocated funding of €500,000 for the refurbishment and upgrade of Muine Bheag Fire Station in the 2021 – 2022 programme of funding which will greatly enhance the working conditions for firefighters within the station.

Carlow County Fire Service received funding from the National Directorate for a number of Capital Projects during 2021 including:

- → Extensive construction and improvement works at Hacketstown Training Centre
- → Class B Fire Appliance (Delivery expected early 2023)
- → Replacement Breathing Apparatus Compressor for Carlow Town Fire Station
- → Replacement Incident Command Unit
- → Forklift for Hacketstown Training Centre
- → Range of Water Rescue Equipment
- → Range of specialist working at height equipment

Training

The COVID 19 pandemic continued to have a significant impact on the annual training programme. In order to catch up with lost training time, courses were condensed into the April – June period as well as extensive training taking place in October. Firefighters completed a total of 1980 hours training in a range of operational disciplines during 2021.

New training courses were developed to reflect specific risks and hazards within the County. Teagasc Oakpark facilitated a 1-day training session for firefighters in the techniques used to rescue farmers and farm workers trapped in agricultural machinery.

Hacketstown Training & Development Centre

Despite the COVID 19 pandemic having a significant effect on Fire Service Training Programmes throughout the country, during 2021 Hacketstown Training Centre facilitated Breathing Apparatus and Compartment Fire Behaviour Training courses for Laois, Kilkenny, Wexford, Wicklow, Waterford, Tipperary, Limerick, Cork County, Kerry and Meath Fire Services as well as the Irish Air Corps and Irish Defence Forces.

In total, Hacketstown Training Centre hosted training and development courses for a total



of 234 days during 2021, the number of training courses hosted in Hacketstown will increase in 2022 once planned construction and improvement works are completed.

Operations

The number of emergency incidents Carlow County Fire and Rescue Service attended in 2021 was 17% higher than the number attended in 2020. This is a common theme amongst Fire Services across Ireland and can be largely attributed to the less onerous restrictions which were imposed to limit the spread of COVID 19 compared to 2020.





Severe flooding which occurred throughout the County on Christmas Day 2021 as well as a number of severe weather events posed challenges for the Fire Service. False activations of monitored fire alarms in commercial and domestic premises continue to create issues for the fire service and initiatives are being developed to try to reduce them.

Community Fire Safety & Fire Prevention

In addition to its operational activities, Carlow Fire Service was also very active in promoting fire safety and continues to inspect public-assembly buildings in an effort to meet the obligations under the Fire Services Act 1981 & 2003.

Carlow Fire Service takes a proactive role in promoting Community Fire Safety in particular during Fire Safety Week which took place on October 4th – 11th 2021. As part of Fire Safety Week, members of the public are normally invited into our Stations to view our equipment and appliances, speak to Fire Prevention Officers and view

fire safety demonstrations and displays. In the context of COVID 19 all activities took place virtually with daily messages published on our social media pages as well as radio interviews with KCLR and Beat FM. Cathaoirleach of Carlow County Council, Cllr Fintan Phelan officially launched Fire Safety Week on Monday, October 4th.

The annual licensing and inspection of premises was completed in September with publicans, dance and restaurant license renewal applications before the Courts. In total 42 premises were inspected in the run up to the Court date in late September. A large body of work was undertaken to comply with the provisions of the Fire Services Act along with the administrative duties associated with issuing certificates. letters and conditions of license. A number of warning letters were issued to premises owners and occupiers following inspections on foot of complaints by members of the public as well as issues that have arisen post incident and other matters that they have been brought to the Fire Officers attention.

Building Control

The Building Control section actively manages the Building Control Management System and carries out routine inspections of construction projects to ensure compliance with all parts A to M of the Building Regulations during construction stage, validating and technically examining Disability Access Certificates as well as advising members of the public on the system. All Fire Safety Certificate and Disability Access Certificate Applications are now being made through the Building Control Management System.

The Building Control Section worked closely with the newly established National Market Surveillance Office which monitors the quality and standard of construction products offered for sale within County Carlow. A number of inspections of premises who offer construction products for sale within County Carlow received unannounced initial and follow up inspections.

The number of Commencement Notices received during 2021 (192) were 27% higher than the number received during 2020 (151).

Local Authorities Section 26 Fire and Emergency Operations Plan

The October meeting of Carlow County Council unanimously passed the Local

Authorities Section 26 Fire and Emergency Operations Plan.

The Section 26 Plan is a Fire and Emergency Operations Plan, which details a schedule of all organisational elements of the provision of fire and emergency operations by the Local Authority through its Fire Service. It outlines the required organisation structure, personnel, equipment, fire stations, water supplies, training, procedures, all resources and other related matters.

The plan details current arrangements within the fire authority and will also set out strategic plans and targets for the fire authority for the next 5 years.

NDFEM Resilience Fleet

Carlow Fire Service continues to support the work of the National Directorate for Fire & Emergency Management through the management of the Directorate's fleet of 11 Resilience and Training fire appliances. These 11 fire appliances are managed and maintained through Carlow Fire Service and are used by the National Directorate for the delivery of the Fire Service National Training Programme across Ireland for fire officers at all ranks from Recruit to Senior Fire Officer.

Two additional Class B Fire Appliances were purchased and added to the National Resilience Fleet during 2021.

Special Projects

Carlow Town Urban Regeneration Fund

n May 2020, the Department of Housing Planning and Local Government invited applications from Local Authorities for schemes for consideration under the Call 2 for the Urban Regeneration and Development Fund which forms part of the Program for Government. Carlow County Council submitted an application for the Call 2 funding including several of the interventions proposed in 'Project Carlow 2040'. Project Carlow 2040 is a regeneration strategy adopted by Council to transform Carlow into a regional powerhouse with sustainable growth and a better quality of life for all.

The total value of the application amounted to €20.8m, 75% of which would be grant aided through the URDF fund.

The Projects

The schemes submitted for consideration were:

- → Railway Link and Public Realm Improvement through Carlow College to Town Centre €2.7m
- → Public Realm Improvement to Tullow St and Dublin St €1.9m
- → Public Realm Improvement to Potato Market €7.8m
- → Public realm improvement and new linkage from Potato Market to Barrack St via Carlow SC €3.0m
- → Barrack St including Shamrock Square and Thompson's Corner/Bus Park €3.7m

→ Public Realm Improvement to Kennedy Avenue €1.7m

The Vision is for Carlow Town to be a high-functioning, inclusive, compact, and accessible town underpinned by a robust and diverse local economy. The aim is to create a vibrant Town Centre providing for a network of linked open spaces, recreational uses and other social infrastructure elements that provides a good quality of life for all.

CCC were formally advised in August that the schemes submitted for consideration had received preliminary approval for the full amount requested. Preliminary approval was also confirmed to move to the next stage of the project life cycle, which in terms of the Public Spending Code is the Preliminary Business Case Stage.



Active Travel

In December 2020 the National Transport Authority invited applications from CCC for schemes to be considered for funding under the Active Travel Programme.

Carlow County Council submitted a comprehensive list of schemes for consideration in January 2021 and were successful in securing initial funding in March of almost €2.5m for active travel

projects and then another €0.46m in outdoor infrastructure funding later in the summer.

The NTA approved the recruitment of four additional staff to assist with the delivery of the Active Travel Programme. This team was established in late 2021 and in the interim works were completed by the MD staff in the delivery of the 'shovel ready' schemes with design work and the statutory consents process ongoing with the reminder.

Carlow Exchange

The project involves the covering over of an existing stone walled vacant site in Carlow town centre. The space will be covered with a bronze effect, standing seam metal roof. The roof itself is lifted above the existing stone walls so as to have minimal impact on the existing historic fabric.

It will be a managed, covered, outdoor civic space of approximately 334 m2. The project contract is for €501,998 ex. VAT.

The expected completion date is the end of July 2022. It is designed to be a flexible open space, suitable for markets, exhibitions, outdoor classes, concerts, shows and group meetings. The structure is designed to be unique within the town centre's urban fabric. It will be immediately identifiable as a civic node and focal point within the public realm.

At night, the building will also be animated with LED lighting, to add to the structure's material palette and reflect its many possible uses.

arlow County Council is the Civil Defence Authority for the administrative area of County Carlow. The 2003 Civil Defence Act sets out a number of roles for Civil Defence. Among these roles are providing a backup service to the Primary Emergency Services; Community Service; Training in Casualty; Radio Communications; Rescue; Welfare; Fire Fighting and Boating Skills (search and recovery). Civil Defence also provides service to the Local Authority, Health Service Executive, and the Gardai in the event of severe weather conditions such as flooding and snow. Civil Defence also provide in emergency situations Radiation Monitoring.

The Major Emergency Management
Framework document also sets out roles
and responsibilities for Civil Defence in the
event of emergencies, such as setting up
Welfare Centres, Registration of Casualties,
responsibility for casual volunteers and
Secondary Line back up to the Principle
Response Agencies.

The members of Carlow Civil Defence are all volunteers except for the Civil Defence Officer who is employed as CDO on a parttime basis by Carlow County Council. At present Civil Defence have over 54 volunteer members ranging from locations such as Carlow town, Muinebheag, Borris and Rathanna. Weekly training on subjects such as First Aid to CPR level, First Aid Responder, Emergency First Responders, Emergency Medical Technician, Fire Fighting skills, Swiftwater Rescue techniques, Technical

Rescue, Search Skills, Welfare etc., are taught and practised. On our training schedule at weekends the subjects taught are exercised and the skills resulting from this are pitched against other counties in competition at various venues.

Civil Defence Boat units provide backup assistance to the (PRAs) Fire service and Gardai in River Search and Recovery (RSR) situations. Volunteers are trained in Boating skills, River and land search and recovery techniques for back up situations to Gardai. Water awareness and Swift Water Flood Response courses are run throughout the year.

In 2021 Carlow Civil Defence were continuing to help with Covid-19 operations. Covid operations consisted of looking after the Health and Welfare.

Carlow's Pride of Place 2021

Due to COVID-19 restrictions, the 22nd Carlow's Pride of Place Awards Event was adapted from an awards night to a partnership with KCLR and the Council where the awards were announced by independent Judge Gary Graham over 3 days on the Eimear Ní Bhraonáin Show on KCLR Live, with it culminating in a 2-hour broadcast show on the 4th day, 21st October 2021, where the overall winners were announced, together with guest speakers.

This year 116 residents' associations & 19 Tidy Towns Groups entered Carlow's Pride of Place Competition. The overall winner of the Towns and Villages was Rathanna and New Oak Estate was the winner of the Overall Estates category. Jim O'Reilly received the Community Spirit Award. 60 cash prizes were awarded to Community Groups across the county, totaling over €16,000.

The Plots Community Allotment Project

Following a lull in operation due to the pandemic, the Plots Community Allotments formed a new committee in 2021 and continues to operate successfully and with direct support from Carlow County Council. 14 meetings took place in relation to the Plots Community Allotments in 2021.







Carlow Pride of Place Awards

Residents Association Work

18 meetings took place in 2021 to support the formation and running of Residents Associations in Carlow Town. 2 new Residents Associations were formed in Carlow Town and are operating successfully.

Bagenalstown Community Work

There were 11 meetings of the Bagenalstown Area Steering Group between June and December this year. This group have been responsible for several successful projects and community improvements for the town.

Community Development Work

- → The community worker supported 4 applications for funding between June to December, 3 of which were successful amounting to €20,200 in value.
- → 9 meetings to support the inter-agency shared usage agreement of the Tullow Road Pitches.
- → 6 meetings to establish new community support in Clonegal.
- → Supported 19 community projects amounting to €20,300 awarded via the Building Community Leadership fund 2021, these included community clean ups, allotments, social inclusion, social media training, community events.
- → Support is continuing for the New Oak Community Centre. Carlow County Council supported the development of an energy audit report for the centre. This will enable the centre to apply for the SEAI Better Communities Grant in 2022.

Carlow Traveller Interagency Group

Carlow Traveller Interagency Group (TIG) monitors the implementation of the actions contained in the Interagency Traveller Strategy. Work continued remotely during 2021 and four meetings were held, while the Thematic Working Groups met bi-monthly.

Following a successful funding application for €17,400 to the Department of Justice & Equality a part-time Community Development Worker has continued to be employed through St. Catherine's Community Services Centre to develop and support the Carlow Traveller Forum. Work commenced

on the Assessment of Need and Strategic Plan 2021-2024.

Tullow Road Community Hub Project

County Council propose to construct a multi-functional community hub at Tullow Road, Carlow at a cost of €2.5m approx. This project will facilitate new and existing supports and services, catering for physical. social and community needs. The main constituents of the facility are broken down into three main areas: (1) General Administration, (2) Social Areas and (3) Activities spaces. The tender for the design of the Tullow Road was awarded to Kenneth Hennessey Architects in February. In June, a workshop took place with the Carlow MD Members to review Draft Design Plans for the Tullow Road Community Hub building. This was followed by a community drop in information event on the Draft Design Plans for the community which took place on the Tullow Road Community Pitches. There was an overwhelmingly positive response to the plans. The Part 8 process commenced in July with closing date for submissions on the 8th of October 2021. The Council approved the Part 8 planning process in December 2021 for this project.

Healthy Carlow

The Community Section of Carlow County Council administers the funding and supports Healthy Carlow. The LCDC Sub-Group includes representatives from

The wellbeing of our older community members and the increased loneliness felt due to social isolation had a catalyst effect on our programming in 2021. Initiatives such as Mobile Music Machine and Borris Lace by Post, where creativity in older people was at the forefront, was prioritised.

Through the Carlow Arts Service the following programmes were led, supported, and nurtured in 2021:

- → Carlow Writer in Residence managed by the Arts Service in partnership with Carlow College, Car-low Library Services and the Arts Council of Ireland had a very successful year.
- → Culture Night Carlow returned in September with Carlow Arts Service managing a programme which called on participants to 'Come Together Again'. The

- programme showcased 12 events, over 5 venues in the county, 3 taking place online, engaging 9 local artists and 4 performing groups with audience figures totaling over 420.
- → Carlow Arts Festival became the first festival of the year to host live events in 2021. 81 live performances were delivered to real live audiences over the ten daysnot counting the endless visitors that continued to experience the Woman in the Machine exhibition at VISUAL throughout the summer, enjoyed the mural by Maser across from Carlow Courthouse, and all of the online audiences that enjoyed the virtual events and the extensive #OnDemand film series.
- → Carlow Youth Theatre managed by Carlow Arts Service provided 15 young people aged 11-13 years and 24 young people aged 14-18 years, with weekly zoom theatre workshops.

- → Take A Part Carlow worked collaboratively with community representatives, artists, and stake-holder partners to deliver high quality socially engaged art projects on the Tullow Road such as: Tullow Road Community Choir, 'Turn It Up' spoken word poetry workshops, Love To Draw, Street Art in the Skate Park Project and the "Take Over" Youth Reach Project. The Arts Action Group represented County Carlow in the 2021 Co-Operation IPB Pride of Place Awards and was shortlisted for two awards.
- → Carlow Arts Service worked with the Arts Council of Ireland and Local Government committee members in the planning stages

- of the third Places Matter Conference which will be hosted in VISUAL Carlow in March 2022.
- → Platform 31 a pilot project for a nationwide artists development scheme in collaboration between the Association of Local Authority Arts Officers (ALAAO) and the Arts Council of Ireland supported and enabled career development for 31 mid-career artists in all art forms across the country. Cian Kinsella was Carlow's successful artist. He received a €8,000 bursary to invest in his practice and he benefited greatly from participation in a developmental and networking framework.



Museum Board

In January 2021, Cllr. Ken Murnane was elected the Chairperson of the Board of Carlow County Museum for 2021. He succeeded Mr. Padraig Dooley.

Covid-19*

The Museum, in accordance with the Government Covid-19 restrictions and guidelines the Museum and Tourist Office reopened to the public on Friday May 21st with protocols such as pre-booking, contact tracing and social distancing. The Museum and Tourist Office was granted the Fáilte Ireland Covid-19 Charter which assures visitors that the premises is Covid-19 protocol compliant. As a result of the restrictions the Museum only welcomed 1,500 visitors, our lowest number.

Museum Standards Programme of Ireland (MSPI) Award

Carlow County Museum received its award of Interim Accreditation under the Museum Stand-ards Programme for Ireland (MSPI),

coordinated by the Heritage Council, in a virtual award ceremony that was held on February 3rd. The County Museum is the first museum in the county to both participate in the MSPI programme and to be accredited.

Archaeological Finds

Carlow County Museum is Designated by the National Museum of Ireland (NMI) to collect and display archaeological finds. In 2021 the Museum received on loan from the NMI the Killinane Bronze Age Vessel and accompanying tiny rock crystal. This Bronze Age vessel and rock crystal was found in July 1982 in the townland of Killinane, near Bagenalstown, County Carlow.

The History Fix, KCLR96FM

Through the Creative Ireland Carlow programme, the Museum collaborated with the KCLR96FM 'The History Fix' show to bring some of Carlow's history to the fore. Topics included links between Carlow and calculating the date for Easter; life and times of Arthur MacMurrough Kavanagh of

Borris House; the 100th Anniversary of the Ballymurphy Ambush and Tullow na-tive Thomas Traynor who was executed one hundred years ago in Mountjoy Gaol for his part in the Irish War of Independence. All the shows can be listened back to on the KCLR96FM web-site.

Irish Conference of Historians:

The 33rd Irish Conference of Historians took place online on Thursday 20th and Friday 21st of May 2021. Carlow County Museum presented a panel on Thursday May 20th to kick off the conference on, 'Re-discovering St. Willibrord, Patron Saint of Luxembourg, First Apostle of the Netherlands and his County Carlow Connection', with three presentations by Prof. Emeritus Dáibhí Ó Cróinín, Department of History, NUI Galway; Michel Summer, PhD candidate, Trinity College; and Dermot Mulligan, Museum Curator, Carlow County Museum.

Methodist Church 1899 Tablecloth

Under the Regional Museum Exhibitions Scheme 2021 by the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media, the Museum received a grant for the conservation and mounting of a beautiful 1899 tablecloth from the Carlow Methodist Church.

This tablecloth contains the hand stitched signatures of 183 people who attended a church building fund raising 'Bazar and Sale of Work' in the Town Hall, Carlow Town, on Saturday May 13th, 1899.

International Museums Day 2021

International Museum Day 2021 was held on Tuesday May 18th. The Local Authority Museums Network (LAMN) partnered with the International Council of Museums (ICOM) Ireland and the Irish Museums Association (IMA) to mark the day online. This was done though an online exhibition titled 'Artefacts of Rebellious Ireland, Stories from around the Country'.



Kevin Barry Death Mask

On Monday June 24th, Ian Dowling, Dublin, loaned the Death Mask of Kevin Barry to the Muse-um for one year. This death mask was cast shortly after his death, how and by whom is not known. The death mask, and brooch were in the procession of Kathleen Napoli McKenna, who amongst other things was the private secretary to Arthur Griffith, head of the Irish delegation during the Anglo-Irish treaty negotiations in 1921, in London.

Ian is a cousin of Kevin, and he previously brought the mask to the Museum in October 2021 for the 100th anniversary of Kevin's death on November 1st, 1920. The death mask and the re-mains of Kevin's last cigarette, displayed in the Museum, appeared with Ian on the RTE Late Late Show on Friday 19th of February.

Museum Website

A new Museum website was launched by Cllr Ken Murnane, Mayor of the Municipal District of Carlow and Chairperson of the Board of Carlow County Museum. The launch coincided with 48th anniversary of the museum's opening in December 1973. The new website can be visited at www.carlowmuseum.com

16th Century Effigy of Robert Hartpole

Under the Community Monument Fund 2021 by the Department of Department of Housing, Local Government and Heritage, Carlow County Council, through the Museum, were awarded a grant for the care and conservation of the late 16th century Hartpole Effigy (LA005-032) and its relocation from The People's Park, Portarlington, to Carlow County Museum, Carlow Town, a Designated Museum, for permanent display. The Museum worked over several years with the Laois Heritage Office, the National Monuments Service. the National Museum of Ireland and the Carlow Historical & Archaeological Society in bringing this important project to fruition.



Reading & Literacy:

Literacy-Friendly County Carlow

work continued this research project throughout 2021, supported by members of the Right to Read Net-work. The research report was completed and work on accompanying materials commenced. The overall aims of the project are to identify the key literacy issues in Carlow, including the barriers and supports available. This is a first step in raising awareness of unmet literacy needs in Carlow with the hope of fur-ther developing the Literacy-Friendly County Carlow initiative. This project was made possible by fund-ing from Dormant Accounts and Carlow County Council.

Ireland Reads

For the inaugural Ireland Reads initiative library staff created promotional materials to encourage use of Borrow Box to borrow items while libraries were closed. Over 900,000 reading minutes were pledged countrywide on Ireland Reads Day on 25th February.

Little Library Bags

Almost 50 Early Learning Centres (ELCs) throughout the county took part in the Little Library book bags initiative which took place in May and November on collaboration with Carlow County Childcare Committee.

Spring into Storytime

Online story time videos created by library staff were posted on the Carlow County Library Facebook page in April. These were viewed a total of 1,494 times. An online Rhyme & Sign Storytime session taught parents to communicate with their baby before they can talk.

Schools Library Ninja Challenge

Almost 600 pupils from three primary schools participated in the Ninja Challenge in May and June 2021, with each school receiving resources.



- → Anglo Irish Treaty A 16-page supplement in the Carlow Nationalist was issued to mark the signing of the Anglo-Irish Treaty one hundred years ago.

Local Studies, Archive and Genealogy Service:

The public library is a curator of memory and is responsible for creating, storing and making accessible local cultural and historical records. During 2021, there were almost 800 enquiries to our Local Studies/ Genealogy Department via email, telephone and in person visits.

Programming:

- → As part of the Keep Well Campaign, the Grow It Forward Campaign was launched on 23rd March, a partnership between Healthy Ireland, Libraries Ireland & GIY (Grow It Yourself). 50,000 free food growing kits were given away and participants were asked to use the kits to share the experience with ten people, enabling half a million people across Ireland to enjoy the wide range of benefits that come from growing food at home.
- → To mark Bealtaine, a Genealogy Workshop, an Introduction to Tracing Your Family History with Bernie Walsh, Genealogist was held on Zoom.
- → An article on the Re-opening of Public Libraries featuring an interview with John Shortall, Coun-ty Librarian talking about the re-opening of Carlow Library Service was published in the Irish Times on Monday 17th May.
- → There was a free LinkedIn Webinar with Joe Morris held on in June. This Webinar was aimed at jobseekers, career changers and new graduates. This webinar was part of the Work Matters At Your Library Programme of Events.

Learning & Information

Healthy Ireland

In 2021, Healthy Ireland at Your Library events took place online as follows:

- → A 4-week term of Baby Sign Language Classes aimed at parents and babies ran in early 2021via Zoom facilitated by Claire Glynn of Clever Little Handies.
- → Clinical Psychologist, Dr. Eddie Murphy delivered an Online Workshop via Zoom called "Well-being In Strange Times" in February.

- → A workshop took place in May called 'Healthy Gut, Healthy You' and was delivered on Zoom by Gillian McConnell, Qualified Dietician with Inside Out Nutrition.
- → A free zoom webinar held in July called "Perfectly Imperfect Parenting" with Dr. Mary O'Kane, Psychology & Education Lecturer.
- → Registered Dietician, Gillian McConnell (Inside Out Nutrition) who specialises in digestive dis-orders was back for a second workshop called "Boost Your Mood with Food" in October.

Grant Funding

Dormant Accounts:

Funding of €13,157 was approved in 2021 for a range of supports including programming and capital funding for Digital Equity and Social Inclusion. Supports provided include:

- → An interactive touchscreen table for Carlow Central Library
- → A C-Pen reader scanner for each library branch
- → Irish Sign Language classes and a series of filmed storytimes
- → Dream Big a STEM programme with Niamh Shaw and Askea Girls NS

Design Thinking:

Funding of €1,500 was provided for materials to support our Design Thinking project. Six Samsung Galaxy tablets for use in a digital literacy library programme for older adults.





n 2021 Carlow County Council employed a Heritage Officer below is a list of funding secured for heritage services within our County.

- → Secured funding for a Heritage-Led Regeneration Plan for Carlow Town under the **Historic Towns Initiative**. The production of the plan will be the first step in future applications to fund the implementation of the plan.
- → Secured funding for four heritage projects in County Carlow under the Heritage Officer Fund from the Heritage Council. The projects are a Study and analysis of vernacular structures in the Blackstairs Mountains; Facilitation services to assist with public consultation of the Heritage Plan; Production of videography to tell the story of the Gordon Bennet Race (collaborative project with Kildare, Laois and Carlow Heritage Officers) and a Pilot Study to identify how to ensure in-clusion of all children's voices in heritage surveys.
- → Received Departmental approval for funding of seven applications in County Carlow in response to the open call for funding under the Built Heritage Investment Scheme.

- → Assessed and forwarded three applications for County Carlow under the Historic Structures Fund, in addition to the Local Authority's application for proposed conservation works at Tullow Courthouse, Tullow.
- → Submitted two grant applications under the Community Monuments Fund. One application was received from Carlow Historical and Archaeological Society and the second was produced by the Heritage Officer on behalf of Carlow County Council for funding for a Conservation Management Plan for St. Michael's Church and Graveyard, Tinnahinch, Carlow.
- → Submitted a funding application for three biodiversity projects on behalf of Carlow County Council under the Local Biodiversity Action Fund.
- → Supported eight applications for funding for County Carlow under the Heritage Council's Community Grants Scheme and Heritage Stewardship Scheme.
- → Engaged with several local community groups and heritage stakeholders.











Local Operating Environment
