6.1 Standing in the name of Cllr. Adrienne Wallace

"Noting that there are gaps in the way that public bodies provide some services, and some facilities are not easily accessible to those with disabilities. Access Officers will help to systematically work to address these gaps and ensure that future services and facilities comply with national guidelines, standards and legislation, and are fully accessible to everyone.

Additionally, in accordance with section 26(2) of the Disability Act 2005 every public body is legally obliged to have an access officer and with the Optional Protocol to the UN Convention on the Rights for people with disabilities due to be ratified; increased resources and support for people with disabilities is an urgent necessity.

As such Carlow County Council will move to immediately employ a full-time Access Officer.
