Members noted correspondence from Westmeath County Council calling on the Minister for Education to remove the mandatory aspect of secondary level Social Personal and Health Education (SPHE) classes and that the entire SPHE curriculum would be reviewed.

Additionally, in accordance with section 26(2) of the Disability Act 2005 every public body is legally obliged to have an access officer and with the Optional Protocol to the UN Convention on the Rights for people with disabilities due to be ratified; increased resources and support for people with disabilities is an urgent necessity.

As such Carlow County Council will move to immediately employ a full-time Access Officer.
