That Carlow County Council upholds its policy of "mixed tenure communities" across the whole county by implementing affordable housing schemes in current and future housing developments."

6.5 Standing in the name of Cllr. A Wallace

"This council regretfully notes that the numbers of families and individuals in homeless accommodation continues to rise each month and that the government is failing to reach its own targets for new social and affordable homes.

We therefore condemn the recent guidance note to councils from the Department of Housing, Local Government and Heritage (DoHLGH) limiting the numbers of homes that can be bought under Tenant in Situ and other programmes.

We call on the Minister to immediately rescind the recent guidance note and to ensure that all councils have the necessary funds and powers to purchase any and all homes to prevent evictions and to increase their stock of social and affordable homes."

Proposed by Cllr. A. Wallace Seconded by Cllr. J. Deane And following a show of hands the motion was defeated.

6.6 Standing in the name of CIIr. A. Wallace

"Noting the record housing crisis, Carlow Council calls on the Department of Housing, Local Government & Heritage to apply the demands outlined below to alleviate the crisis for people in Carlow:-

- Increase the supply of social and affordable homes so that social and cost rental housing accounts for a minimum of 20% of the total housing stock per the Housing Commission Report.
- Reinstate a moratorium on evictions to stem the tide of private renters into homelessness.
- Direct local authorities to prioritise households in emergency accommodation for intensive case management to facilitate exits out of homelessness – this should include increased resourcing for case managers, local authority social work sections and appropriate support services.
- Direct local authorities to establish new allocation procedures to give fairer access to housing for those in long term homelessness – including schemes like Housing First.
- Draft legislation requiring local authorities to regard the best interests of children when responding to families presenting as homeless."

Proposed by Cllr. A. Wallace Seconded by Cllr. J. Deane And following a show of hands the motion was defeated.

6.7 Standing in the name of Cllr. W. Paton

"That Carlow County Council calls on the Minister for Further and Higher Education, Innovation and Science, Patrick O' Donovan, to make a final determination on the new veterinary and pharmacy programmes for the South East Technological University before 1st October, 2024 - so that arrangements can be made to commence such student registration by 1st September, 2025."

Proposed by Cllr. W. Paton Seconded by Cllr. A. Dalton And agreed following a show of hands.

6.0 Any other business with the consent of the Cathaoirleach/Aon gnó eile le haontú an Chathaoirligh

Cllr. W. Paton raises issue with lack of spaces on school bus from Rathvilly to Tullow.

Cllr. C. Murphy raised concern regarding drug use.

Cllr. Cassin raised issue with road condition of Tullow Street up to Shamrock Square.

Members expressed concern regarding a new road sign at the Junction 5 roundabout at Tinryland which is causing confusion for drivers using the roundabout.

Members expressed concern regarding closure of road at Mill Street Tullow.

Cllr. A. Wallace queried Carrigbrook housing estate and need to level open space area.

Cllr. J. Pender raised concern for road safety on the N80 Carlow to Bunclody and particularly at Cross Roads junctions and looked for update on Leagh Bends and possibility of a safety audit being carried out.
